Story City Municipal Electric Utility Trustees Board Meeting Minute

For May 21, 2024

Story City Municipal Electric Utility Trustees met at the Distribution Office on May 21, 2024, with the meeting called to order at 4:00pm by Linda Narigon. Attendees: Linda Narigon, Ty Gustafson, Chris Isebrand, and Admin. Jake Froehlich. City Council Representative Connie Phillips was absent from the meeting. Also, in attendance SCMEU Accounting Clerk Felicia Lucas and Phil Waniorek Jr. with Benefits, Inc.

Review of April 17, 2024, Board Meeting Minutes. Narigon moved to approve April 17, 2024, seconded by Gustafson. Motion carried.

Phil Waniorek Jr. with Benefit, Inc. along with SCMEU Accounting Clerk, Felicia Lucas, were on hand to discuss the Third-Party Administrator (TPA) the Utility currently has for their employees benefit package. Lucas is requesting the board approve the transition to Benefits Inc. for their services. Waniorek explained their services and what they could provide. There was additional discussion on Health and Dental plans for possible future changes. Benefits Inc. is also used by the City of Story City and has been for several years. The Board discussed the proposal and tabled the subject for further discussion at the June meeting once they had a chance to review the packet provided by Waniorek and are able to discuss with City of Story City staff.
